11/69 Fire Procedure

11/76 Parking Restrictions

Councillor Shirley Jones reported that parking restrictions on numerous roads in Alsager had now been approved by cabinet and work would be completed during the summer.

11/77 30 mph sign - Crewe Road

Councillor Jones raised concerns regarding the 30mph signs on Crewe Road after the turning for Close Lane and asked for the Town Councils Planning Committee to consider making representations to Cheshire East Council for a 30mph sign to also be placed on the road and to also give consideration to the repositioning of the 30MPH speed limit sign on Crewe Road from its existing location to Radway traffic lights.

Resolved: That, Cheshire East be written to asking for a '30mph' to be painted on the road, and consideration be given to extending the 30mph zone to Radway traffic lights.

11/78 CEC Proposed Surface Dressing Programme

The Chairman reported that information had been received from Cheshire East Council regarding a proposed surface redressing programme due to commence in mid July until the end of August. No roads were included in the programme for Alsager.

11/79 Local Highways Issues

Councillor Mrs H Robinson reported on issues that residents had raised with her regarding heavy goods vehicles along Linley Lane and a trapped Drain on Hassall Road. Councillor R Fletcher explained that any highways faults can be reported direct to Cheshire East at Alsager Library.
