Councillor D I Hough responded by indicating that Alsager has already had its quota of housing and any further developments will be subject to CIL, but the policy is yet to be passed. CIL from other developments in Cheshire East will contribute to the priority 123 list of which Bank Corner in Alsager forms part of the list.
