### Section 3 – External Auditor Report and Certificate 2018/19

In respect of **Alsager Town Council – CH0010**

#### 1 Respective responsibilities of the body and the auditor

#### 2 External auditor report 2018/19

On the basis of our review of Sections 1 and 2 of the Annual Governance and Accountability Return (AGAR), in our opinion the information in Sections 1 and 2 of the AGAR is in accordance with Proper Practices and no other matters have come to our attention giving cause for concern that relevant legislation and regulatory requirements have not been met.

Other matters not affecting our opinion which we draw to the attention of the authority:

In the completion of the Annual Internal Audit Report, the internal auditor has drawn attention to significant weaknesses in relation to the Council's controls around petty cash. However, the Council has provided the appointed auditor with details of the actions undertaken to address this weakness and an adequate explanation as to why they felt it appropriate to answer 'Yes' to AGS Assertion 2.
